Woodford Country Markets Risk Assessment Guidelines and Terms & Conditions

All stallholders are bound by the Stall Holder Risk Assessment Guidelines and the Terms and Conditions. Please familiarise yourself with this document. When you book your stall, you will be deemed to have read these terms and be agreeable with these terms and conditions. These rules are to protect you the trader, and to protect the local community. They ensure that we can provide everyone with a quality event, and help us strive to provide you with an enjoyable trading experience.

1. Drop off and set up time is from 5am for a 7am start.
2. Pack up time is 12 and 1pm
3. **For the duration of the markets all stallholders must park behind the Woodford Community Hall.** There is a ramp for access. If anyone has mobility problems please ask for help. For those unloading on Archer Street please park on the left hand side of the road, not on the right.
4. Site fee is payable on the day.
5. Sites must be left clean and tidy.
6. All stalls must face in towards the centre of the area. No stalls are to face out to the roads (D'Aguilar Highway and Archer Street.)
7. No spikes are to be put into the ground. All structures must be freestanding.
8. Public Liability Insurance Policy's must be current and be presented to Woodford Historical Society one week prior to market day.
9. Food Licences must be current and presented to Woodford Historical Society one week prior to market day.
10. Please refer to the inclement weather cancelation plan for bad weather.
11. All signage must stay within the market area and be to MBRC standards.
12. The map supplied shows permanent stallholders sites. If you are not sure where your site is please ask a Woodford Historical Society member or their representative.
13. All complaints are to be directed to a Woodford Historical Society member.
14. No animals are allowed excluding seeing eye dogs and assistant dogs.
15. If you notice anything out of place, damaged or broken in the area notify a Woodford Historical Society member or take a photo of it for documentation for MBRC.
16. The Stallholder releases and indemnifies Woodford Historical Society against any claim arising from any:
 - a. loss, damage, death or injury to any property or person in or about the Market caused or contributed to by the Stallholder or any use of occupation of the Stall by the Stallholder;
 - b. neglect or default of the Stallholder; or
 - c. any combination of those things.
15. Stallholders are required to comply with relevant local government and relevant legislation and codes in relation to the sales of food, food handling and storage.
16. Woodford Country Markets supports Ban the Bag for single use plastic bags.
17. Damages or Loss: You participate in this event at your own risk. By booking a stall, you fully accept that you are trading in the outdoors, where you will be exposed to the elements and you need to bring your own shelter with you. You accept that fair stall trading is therefore an outdoor activity and as with any activity comes some risk. By participating in the event you indemnify the organisers of the event against any damage, loss or injury to yourself or any of your belongings, or vehicle, that may result in participating in the activity. You are responsible for the security and supervision of all of your goods and belongings whilst at the event. Event organisers will not accept any damage or loss incurred whilst participating in the event.
18. Safety of site: You are not permitted to leave any boxes, goods, ropes, or protruding tent pegs, which may cause trip hazards, which may cause injury to any person. You are responsible for keeping your site safe and tidy, and will take full responsibility for any injury or damage to any person or personal object if that injury is a result of negligence or an unsafe activity or action on your part.
19. Prohibited items: You are not permitted to sell any item that is illegal, offensive, or unsafe.
20. If an incident occurs notify a Woodford Historical Society member or their representative as soon as possible. An Incident Report Form must be filled out and handed to a Woodford Historical Society representative on the day the incident occurred.
